Membership Classification Descriptions:

*All Memberships are for the calendar year beginning January 1st and ending December 31st *

Family Golf: Family unit with Two (2) or more Golfers with Full Privileges.

Single Golf: One (1) Golfer with Full Privileges.

Senior Limited Golf: One (1) Golfer. 60 Years of Age or Older. Weekdays Only Excluding Holidays and you must tee off by 11:00 Am or make the turn by 11:00 Am for an 18-Hole Round. Senior Limited Membership Dues must be Paid in Full by June 30th.

Student Golf: Junior Golfer beginning at the Age of 14 and up to age 18; or enrolled in full-time Secondary Education up to the Age of 24. Junior policies and procedures must be followed. Student Membership Dues must be Paid in Full by June 30th.

<u>Social Membership:</u> Full use of all clubhouse facilities. Have access to all social functions or events. Play golf up to three times a year upon payment of Green Fees, with authorization in advance from pro shop staff.
